Gentlemen:

As you know, the Commonwealth's General Fund is currently facing unprecedented fiscal challenges. Since taking office on January 18, 2011, I have been able to confirm a projected shortfall in the General Fund for fiscal year 2010-11 and a deficit of over \$4 billion for fiscal year 2011-12 based on preliminary projections.

While the immediate priority of the Administration is to develop a balanced 2011-12 budget proposal for presentation to the General Assembly and the citizens of Pennsylvania on March 8, 2011, Governor Corbett requested the Budget Office assess options to reduce state spending in the current fiscal year. In light of the fact the General Fund has ended each of the last two fiscal years in a deficit position, the current year shortfall and the enormity of next fiscal year's budget deficit make immediate action imperative to begin to bring the General Fund back into balance.

To that end, Governor Corbett has directed me to place \$364.3 million of current-year appropriations into budgetary reserve. The appropriations and dollar amounts are shown on the attached list. The reduction in the state Basic Education Funding appropriation will be offset by federal Education Jobs Fund monies that have not yet been appropriated by the General Assembly. The federal government made these funds available to states in August 2010 to be awarded on a timely basis to school districts during the 2010-11 school year. I will follow up this letter with a request for the General Assembly to enact a federal appropriation for the Education Jobs Fund monies and a corresponding reduction in the state Basic Education Funding appropriation. With this action, no school district will receive less funding than was originally included in the enacted budget signed by Governor Rendell on July 6, 2010, including restoring

\$50 million in funding that was placed into budgetary reserve in August 2010. The other amounts placed into budgetary reserve are funds for discretionary grants that have not yet been expended.

By placing these funds into budgetary reserve, the Commonwealth's General Fund will be in position to end the current year with a surplus and our agencies will still be able to provide essential services to the citizens of Pennsylvania. I look forward to working with you on this issue and our mutual efforts to put the Commonwealth back on the path to fiscal stability.
